Important Information to Consider

Throughout this course participants will be required to apply and receive make-up applications during face-to-face training sessions. Participants should consider if this is something they are comfortable with prior to enrolment.

STUDENT ELIGIBILITY REQUIREMENTS

Applicants must meet the following minimum entry requirements:

- 17 years of age at time of enrolment
- Completion of Year 12 or equivalent, or demonstration of skills and knowledge at a similar level
- Upper-intermediate level of English proficiency, equivalent to IELTS 5.5 or higher

Applicants who have not completed Year 12, or who are under 17 years of age at the time of enrolment, may be considered on a case by case basis. Please contact us to discuss your individual circumstances prior to applying.

All applicants are required to participate in a pre-enrolment interview to assess suitability, readiness and commitment to Diploma-level study.



Career Opportunities/Vocational Outcomes

Upon successful completion of the Diploma of Screen and Media Specialist Makeup Services, you will be qualified to work as a specialist makeup artist in advanced creative and screen-based environments, either as part of a professional production team or as an independent freelance artist.

Career outcomes may include working as a specialist makeup artist in areas such as film and television productions, screen and media projects, SPFX and prosthetics, fashion and editorial campaigns, commercial advertising, theatre productions, high-end bridal and event styling, corporate and brand activations, creative direction projects and professional photography studios.

Articulation Pathways from the Qualification

On completion of this qualification, graduates may choose to undertake further specialist study within the screen and media industry. Pathways may include progression to the Advanced Diploma of Screen and Media (CUA60620) or other related higher-level qualifications within the Creative Arts and Screen and Media training package.

ASSESSMENTS

Assessments for the Diploma of Screen and Media Specialist Makeup Services are designed to ensure that each student demonstrates competency in all unit requirements. Assessment tasks are built into every Unit of Competency and reflect the advanced technical, creative and professional standards required at Diploma level.

A variety of assessment methods are utilised throughout this course and may include, but are not limited to:

- Learner workbook activities
- Written assessments
- Research and project briefs
- Portfolio submissions
- Self Reflection journals
- In-class observations by educators
- Evidence sheets
- Case study analysis
- Practical demonstrations and industry-simulated tasks

You will be required to submit any relevant written assessment or portfolio of evidence prior to the scheduled assessment date or bring it with you as directed. If face to face assessment is being undertaken, attendance is compulsory.

If you are unwell or unable to attend, a written request must be submitted via email to advise of your absence and arrange an alternative assessment date. This may incur an additional cost.

Students are required to supply their own laptop for written and digital assessment tasks and maintain access to reliable internet. All students must also source their own models for assessment days. The Art of Makeup Society is not responsible for supplying or arranging assessment models.

Assessment due dates are clearly communicated and are expected to be met. If exceptional circumstances arise, an extension must be requested in writing prior to the due date and will only be granted where appropriate. Late submissions without prior approval may result in a Not Yet Competent outcome.

Student Selection

Each applicant will participate in a pre-enrolment interview to:

- Confirm the applicant understands the expectations, workload and commitment required at Diploma level
- Assess readiness for advanced creative and technical study
- Explore opportunities for Recognition of Prior Learning (RPL) and/or credit transfer
- Identify any individual needs and determine whether reasonable adjustment is required
- Establish suitable delivery modes that match the applicant's circumstances and learning capacity
- Confirm the applicant is prepared to meet professional standards, including sourcing models, maintaining equipment and meeting assessment deadlines
- Provide clear information regarding important policies and processes including admissions, privacy, fees and payment schedules, refunds, complaints and appeals.

The interview process ensures that students enrolling into the Diploma are genuinely committed, prepared for the level of responsibility required and entering the course with clear industry intentions.



REASONABLE ADJUSTMENT

If you have a permanent or temporary condition that may prevent you successfully completing the assessment task(s) as written, you should immediately discuss the process of applying for a 'reasonable adjustment' with you Facilitator. This will enable us to adjust the way in which you are assessed, taking into account your condition. This may include providing additional time, or the addition of a support person. While assessment tasks may be changed to suit your condition, the actual performance criteria cannot be altered.

Recognition of Prior Learning and Current Competency

GEM College of International Business recognises skills gained through previous studies, the workplace and life experience which may allow you to complete your qualification more quickly than the nominated minimal hours.

You may be entitled to recognition that will exempt you from one or more Units of Competency. Where you can provide evidence of competency in all Units in a given qualification, you will be required to complete a major project, to demonstrate your ability to provide current application of those competencies across a range of sectors, or with regards to a range of contingencies.

If you are granted RPL the target unit will be reported on your Academic Transcript advanced standing. No gradings are provided for Units granted under RPL arrangements.

You must enrol in all Units of Competency and apply for an exemption by completing a form. Attendance at class or Online is necessary until any relevant exemption is granted.
